## COMBAT VETERAN STRIPPED OF CONSTITUTIONAL GUARANTEES

Paul Griffin's ancestors have been fighting and shedding blood for this nation since The Revolutionary War and were awarded "PROPERTY" as a right, by a grateful founding president, George Washington. As a combat veteran, Paul followed in the footsteps of his ancestors to ensure that this right would remain inviolate. Unfortunately, for Paul and Irene, his wife of forty five years, it has not!

In an egregious infringement of The Griffin's constitutional guarantees to property, due process and equal protection under the law, they stood witness to a complete perversion of our Justice System. With absolute impunity and cloaked in a criminal conspiracy, (RICO) the Griffin's Constitutional Rights were callously fed into a document shredder of religious intolerance; money laundering; bank fraud; wire fraud; tax fraud; contract fraud; corporate fraud; followed by judicial abuse; arrogance; bias; corruption; extortion and apathy.

After forty-five years of hard work, The Griffins were stripped of their business, their home and their life's savings by a villainous and fraudulent debtor, in collusion with corrupted legal practitioners and confounded by frivolous legal process. Furthermore, by means of a fraudulent bankruptcy and four years of a convoluted bankruptcy stay, while **the debtor enjoyed free and exclusive occupancy of the Griffin's seventy acre resort property**, The Griffins were forced to pay for the mortgage, taxes and insurance. After four years of intense litigation, The Griffin's were finally successful in their efforts to evict these criminal occupiers. By this time, these interlopers had so vandalized The Griffin's property as to leave Paul and Irene completely depleted of all that they had worked a lifetime to achieve. By means of fraudulent documentation, a fundamentalist religious congregation from Brooklyn, NY, illegally occupied the Griffin's resort property, [The Meadows Resort](#) in Fosterdale NY,...Seventy acres, one hundred rooms and catering for three hundred people. Shortly thereafter, they filed a fraudulent bankruptcy in the name of a non-existent entity. When their fraudulent filing was disclosed to the court, these debtors were

permitted to file a second bankruptcy, utilizing the tax ID and name of a religious corporation. However, they spent the next ten years denying that they are in fact the debtor, despite the fact that they signed the documents and were the beneficiaries of those documents.



This case was convoluted by legal technicalities for ten years and the substance was never allowed to percolate to the surface. The Griffins have been abandoned by the very system that convoluted the entire judicial process and left Paul and Irene to survive on Social Security and VA Disability. Although this case has generated corrupting legal precedent and was recently submitted to The U.S. Supreme Court, the court declined to hear the case. However, the fact remains that the Griffin's basic Constitutional rights to property, due process and equal protection under the law were completely violated and their protests fell on deaf ears.

America's Founders understood clearly that private property is the foundation not only of prosperity, but of freedom itself. Thus, through the common law, state law, and the Constitution they protected property rights - the rights of people to freely acquire, use, and dispose of property. However, Our Constitution is only as good a restraint upon those who would trample over it as those into whose hands it is entrusted for respect, honor and enforcement.

No American Patriot/Senior Citizen/Combat Veteran should ever have to stand witness to any abridgement nor infringement of those rights guaranteed by our Constitution.
