Former Attorney General John Ashcroft iterated to [The Hague Global Forum on Corruption](#): “Bankruptcy court corruption is not just a matter of bankruptcy trustees in collusion with corrupt bankruptcy judges. The corruption is supported, and justice hindered by high ranking officials in the United States Trustee Program –“. emphasis added. "The corruption has advanced to punishing any and all who mention the criminal acts of trustees and organized crime operating through the United States Bankruptcy Courts. As though greed is not enough, the trustees, in collusion with others, intentionally go forth to destroy lives."

After years of seeking redress for my own issues, I have come to realize that mine is not a small or isolated problem. —**Justice William Rehnquist** stated, “If experience demands a presumption that a judge will seize every opportunity presented to him in the course of his official conduct to line his pockets, no canon of ethics or statute regarding disqualification can save our judicial system.”

My wife and I are senior citizens and I am a disabled combat veteran of The Vietnam Era when I was also exposed to Agent Orange. As the only “real creditors” in a fraudulent bankruptcy, and after forty-five years of hard work, we have been stripped of our business, our home and our life’s savings by a villainous, fraudulent debtor, in collusion with corrupt legal practitioners and confounded by frivolous judicial process. With complete impunity and cloaked in a criminal conspiracy, (RICO) our Constitutional Rights were callously fed into a document shredder of **religious intolerance; money laundering; bank fraud; wire fraud; tax fraud; contract fraud; corporate fraud; judicial abuse; arrogance; bias; corruption, apathy and even extortion** by a judge and a trustee...
